SEASONAL CAMPING AGREEMENT

OPENS 1 May 2021 CLOSSES 30 September 2021

Seasonal lots are 1 October 2020 to 30 September 2021

PAYMENTS \$1,600.00 Full Service

Seasonal fees are due on or before 31 May 2021. Your deposit check will be deducted from the remaining fees. There will be a 5% interest charged on any unpaid balances after 31 May 2021.

A non-refundable \$200.00 deposit will be required for the 2021 season on or before **15TH OF SEPTEMBER 2021** to secure your lot. This amount will be deducted from your 2022 fees.

LOT MAINTENANCE

PLEASE CHECK WITH MANAGERS PRIOR TO PUTTING ANYTHING UP ON YOUR LOT OR ANY MAJOR LOT MAINTENANCE

Fire Pits: Cleaning of fire pits will be the responsibility of lot renters. There will be metal cans provided by the washroom in section A and also by the main dumpsters.

If for some reason you are unable to get to Kerry Park to cut your grass please make arrangements with someone to do it for you. If you are unable to make arrangements, management will hire someone to do it at your cost.

- Lot maintenance is the responsibility of each lot renter. This includes keeping the grass mowed and hedges trimmed. Watering of the trees and hedges are also your responsibility. In the event that the trees or hedges die due to lack of proper maintenance on the renter's part. Kerry Park will not replace them. (If you are unable to do this you can contact Ron and arrangements can be made).
- Mowers, hedge trimmers, grass seed will be available to all renters for your lot maintenance. **Please clean after use and NOTIFY OF ANY BREAKAGE so we can fix for next user.**
- Please place your bags of grass clippings/leaves etc at the end of your driveway and they will be picked up.
- Structures will be based upon their function, appearance and size.
- **Storage Sheds** are to be no larger than **10' by 10'**. **PLACEMENT OF SHEDS MUST BE APPROVED BY MANAGEMENT.**
- Fences are to be no more than **6'** in height on back of your lot and **3'** front.
- **The use of pallets for fences are prohibited.**
- **Gazebos must obtain permission before construction begins.**
- External appliances may be subject to additional fees for hydro usage and must be contained within an enclosed structure approved by Kerry Park structure policy. i.e. Fridge/Freezer

GENERAL

- Recycling is encouraged.
- No excessive barking of dogs allowed. Dogs must on leash at all times.
- Only one trailer per site.
- There will be **absolutely no subletting of your campsite** or assignment of lease allowed. There may be some situations for weekends that you may want to allow someone to camp there. This will only be permitted through both the lot renter and the park manager. People leasing such lots will be responsible for paying regular rates for the amount of leased days.
- Any relocation of Trailers from lot to lot will only happen under the direction of the campground manager.
- All Trailers must be registered and licensed.
- Trailers may be blocked up but must have all wheels on at all times.
- **Absolutely no air conditioners to be left on when campers have gone home. We have situations where people leave their campsites for a whole week and leave the air conditioners on. Should we find this continuing to happen we will charge the camper a fee for the extra unnecessary hydro used.**
- **Also.....please respect when you are using your air conditioner. Keep doors and windows closed.**

Failure to adhere to any of our campsite rules and requirements may result in forfeiture of the lease, without refund and or the right to renew the lease.

Thank you for your co-operation and we hope you have an enjoyable camping year.

- Pets must be leashed and under physical control at all times. It is your responsibility to clean up after your pet.
- **FOLLOW ONE WAY SIGNS PLEASE.**
- Speed limit is **10 Km**
- Quiet time is 11:00 p.m. to 7: a.m. Excessive noise and loud music will **NOT BE TOLERATED**
- Do to fire and safety **ABSOLUTELY NO FIREWORKS** allowed in campground.
- Please turn off your water and air conditioners when you leave your site.
- Please have respect for all campers and Rules.
